UPDATED NOTICE OF AGRICULTURAL LABOR RELATIONS BOARD PUBLIC HEARINGS ON WORKSITE ACCESS

The Agricultural Labor Relations Board (Board or ALRB) will be traveling to key agricultural areas in September 2015 to solicit input from farmworkers, employers and interested members of the public on the Board's proposal to promulgate a rule that permits ALRB staff to visit agricultural work sites for the purpose of educating farmworkers and field supervisors about the rights and responsibilities provided by the Agricultural Labor Relations Act (Act).

- ➤ The public hearings will be held in Fresno, Salinas and Santa Maria. The hearings will be held from 1:00 p.m. to 3:00 p.m., recess from 3:00 p.m. to 4:30 p.m., and resume from 4:30 p.m. to 7:00 p.m. until such time that all public testimony has been received. The public is invited to present your input at either session. It is not necessary to be present during the entire hearing.
- Each facility will accommodate between 150-200 persons.

- The hearing in Oxnard will not be going forward at this time.
